## Hidden Creek Water update with Tracy Tanner-John Tusting

Out attorneys had filed a protest due to last minute change requests by TT regarding water shares in the well. Our attorneys have been unsuccessful in trying to reach TT's water engineer (Don Barnett) to discuss background of the change application. We want to make sure that the change requests are not hurting us and be assured we are retaining permanent assignment of water shares for our HOA and each lot as required before we retract our protest.

#### Insurance

Our insurance agent Lamont Woods of Sentry West Insurance told us that "this HOA has a robust insurance program". Below are the details of our current policy as reported from Jacquelin Rasmussen by email:

We have a Certificate of Liability Insurance
It is a separate page from the main policy, the coverage provides:
Commercial General Liability- \$2,000,000
Personal & ADV Injury- \$2,000,000
General Aggregate- \$3,000,000
Products- Comp/Op Agg- \$3,000,000
Automobile Liability- \$2,000,000
Deductible is 0

Fences/Arbors- \$50,000 Directors & Officers 1,000,000 This Policy provides Defense Cost outside the limit. Deductible is 1,000

Insurance was renewed in October, \$877.00 annual If we want to add an umbrella policy with \$1,000,000 additional coverage It would cost \$750.00 per annum.

## Accountability of leaving rocks on the street

In this case, we think we should at least try to have contractor pay the repair bill who left a sizable (14-16 inch) boulder in middle of the road for the snow blower to pick up which caused significant damage. Andrea will send the bill to the board.

Mike Hyde reminds us of the water diversion problem in Spring Woods that has caused flooding issues to our homes in the past. Since this is a heavy snow year, we will need to address this. Dan Clark (Upper Whittemore HOA President), says we can do nothing until the snow has receded to that point.
